Tell us if any new ECTs will start training at your school in the 2023 to 2024 academic year

We need to know:

- whether or not your school expects any new ECTs
- if you plan to change how you run training for any new ECTs

You can tell us this later if you do not know yet. You can also change your answers if you need to.

Do not include ECTs who started their training in the 2022 to 2023 academic year.

Sign in to the portal via the link:

Follow the instructions on the first page as shown to let the DfE know that you will have a new ECT/s at your school from September 2023 or during the academic year 2023/24

DO NOT include ECTs who have already started their training & are transferring to you from a different school.

* from September 2024, they will stop operating as appropriate bodies






Add ECT or mentor



Once you've added a new ECT and Mentor to the portal with the correct details the you can 'link' them together.

Click on 'Manage ECTs and Mentors'.

From the list of Mentors you have registered you can choose who is to Mentor your new ECT.

This can be done as soon as the details are uploaded.

If the screen says 'Waiting for induction to be recorded', this is because the AB needs to authorise the ECT starting.
