TEACHER REFERENCE NUMBER (TRN)

Information for NPQ participants

The teacher reference number (TRN) is a unique reference number. TRNs are allocated to all those who hold qualified teacher status, or who have ever trained to teach, in England, and all those eligible for the Teachers' Pensions scheme. You do not need to hold qualified teacher status to have a TRN.

If you have a TRN or are eligible to be assigned one:

- Your NPQ provider will need your TRN for their records.
- You will need a TRN to access a NPQ certificate when you complete your course.
- You will also need your TRN when you complete evaluation surveys for DfE.

Please use the guidance below if you are undertaking an NPQ and:

- You know you have a TRN but are unsure / want to check what it is, or
- Do not currently have a TRN and are working as a teacher / leader in England or living in England but not in a teaching / leadership role at present.

I HAVE A TRN, BUT I'VE FORGOTTEN IT / WANT TO CHECK IT

If you do not know your TRN or want to check your TRN, you can contact the Teaching Regulation Agency helpdesk by:

and require a clarification of your TRN.

Email at qts.enquiries@education.gov.uk. Please put the phrase 'Undertaking an NPQ and require TRN clarification' in the subject line. The team aim to respond to valid email requests within 5 working days.

In either case you will need to provide any three of the following information types to have your TRN released to you:

- Full name
- Date of birth
- National insurance number
- Your email address
- The establishment where you undertook your initial teacher training

I DO NOT HAVE A TRN, I AM WORKING/LIVING IN ENGLAND ON AN NPQ PROGRAMME

If you know that you do not have a TRN, then please email the Teaching Regulation Agency at qts.enquiries@education.gov.uk. The team aim to respond to valid email requests within 5 working days.

You will need to provide certain items of information, and confirmatory identification, so we can allocate you a TRN. Please use the free Galaxkey secure email platform to ensure your identification documents are protected.

- Select 'Compose' to start a secure email
- Enter qts.enquiries@education.gov.uk as the recipient
- Input the 'Subject' of the email as: Undertaking an NPQ, do not have a TRN and require a number to be issued
- Please including the following information in your email:
 - State you are undertaking an NPQ, do not have a TRN and require a number to be issued
 - Your full legal name (we will use this to create a record for you)
 - Your date of birth
 - An email address for us to respond to you at
 - Attach a copy of one of the following types of identification as a file to accompany your submission. Please follow the restrictions on file size in the provided guidance:
 - Passport
 - Driving license (full or provisional)
 - Certificate of residence

The Teaching Regulation Agency will use the information you provide to create a permanent record for you and allocate you a TRN. Any copies of personal identification documents you provide will be destroyed once your request is processed.
